## **SEQUANS COMMUNICATIONS**

## **OPEN HARDWARE LICENSE AGREEMENT**

This Open Hardware Design Files License Agreement ("Agreement") is a binding legal contract between you ("You") and Sequans Communications SA, a French corporation with offices at 15-55 boulevard Charles de Gaulle, 92700 Colombes, France, for itself and its controlled subsidiaries ("SEQUANS").

BY ACCESSING using the the enclosed reference designs, schematics, board layouts, and documentation, in hardcopy or cad tool file format (collectively, the "reference material"), you acknowledge that you are agreeing to be bound by the terms and conditions of this agreement. Do not use the reference material until you have read and agreed to the following terms and conditions. The use of the reference material automatically implies the irrevocable acceptance of the following terms and conditions.

**LICENSE**. SEQUANS grants You the right to use, modify, copy and distribute the Reference Material for the purpose of evaluating, testing, and developing application boards based on SEQUANS products. This licese is valid worldwide and for the duration of the aforesaid rights.

**RESTRICTIONS**. Except as otherwise permitted herein, the Reference Material may not be offered for sale, sold, leased or otherwise distributed. You may not use the name, logo, or any other trademark of SEQUANS or any other Sequans company to endorse or promote products derived from the Reference Material without SEQUANS's prior written permission.

**OWNERSHIP**. Title to the Reference Material, related documentation and all copies thereof remain with SEQUANS and/or its licensors. You agree to prevent any unauthorized copying or use of the Reference Material and related documentation.

**NO OTHER RIGHTS**. Except as expressly stated in this Agreement, no right or license, express or implied, is granted to You under any patent, trademark, copyright, trade secret or other intellectual property right of SEQUANS or any other Sequans company.

The Reference Material is addressing only skilled and training technical people and shall be used and managed according to the terms and conditions set forth in the related documentation provided with the Reference Material.

According to European Semiconductor Industry Association (ESIA) letter, "ESIA Response on WEEE Review (May 2008) of the Directive 2002/96/EC of the European Parliament and of the Council on Waste Electrical and Electronic Equipment (WEEE)", Semiconductor products and evaluation & demonstration boards are not in the scope of the aforesaid Directive 2002/96/EC.

You are exclusively responsible for determining whether the Reference Material will be suitable for Your intended use or application or will achieve Your intended results.

SEQUANS shall not have any liability in case of damages, losses, claims or actions anyhow caused from combination of the Reference Material with another product, board, software or device.

SEQUANS has not authorized anyone to make any representation or warranty for the Reference Material, and any technical, applications or design information or advice, quality characterization, reliability data or other services provided by SEQUANS shall not constitute any representation or warranty by SEQUANS or alter this disclaimer of warranty, and no additional obligations or liabilities shall arise from SEQUANS's providing such information or services. SEQUANS does not assume or authorize any other person to assume for it any other liability in connection with its Reference Materials.

All other warranties, conditions or other terms implied by law are excluded to the fullest extent permitted by law.

**LIMITATION OF LIABILITIES**. In no event SEQUANS or its licensors shall be liable to You or any third party except in the case of gross fault or willful misconduct. **TERMINATION**. SEQUANS may terminate this license at any time if You are in breach of any of its terms and conditions. Upon termination, You will immediately destroy or return all copies of the Reference Material and documentation to SEQUANS.

**APPLICABLE LAW AND JURISDICTION.** The Agreement shall be governed by and construed in accordance with the laws of France, without regard to its conflict of laws rules. In case of dispute related to the formation, the performance and/or the termination of this Agreement and in the absence of an amicable settlement, such dispute shall be submitted to the exclusive competence of the Courts of Paris (France), notwithstanding plurality of defendants or introduction of a third party.

**SEVERABILITY**. If any provision of this Agreement is or becomes, at any time or for any reason, unenforceable or invalid, no other provision of this Agreement shall be affected thereby, and the remaining provisions of this Agreement shall continue with the same force and effect as if such unenforceable or invalid provisions had not been inserted in this Agreement.

**WAIVER**. The waiver by either party of any breach of any provisions of this Agreement shall not operate or be construed as a waiver of any other or a subsequent breach of the same or a different provision.

**RELATIONSHIP OF THE PARTIES**. Nothing in this Agreement shall create, or be deemed to create, a partnership or the relationship of principal and agent or employer and employee between the Parties. Neither Party has the authority or power to bind, to contract in the name of or to create a liability for the other in any way or for any purpose.

**PRECEDENCE**. Certain demonstration software available in the open hardware repository may be covered under a separate accompanying end user license agreement, in which case the terms and conditions of such end user license agreement shall apply to that demonstration software. However, if the Reference Material was provided to You in connection with Your purchase of an evaluation board, then solely with respect to the

Reference Material, this Agreement shall take precedence over the Evaluation Product License Agreement between You and SEQUANS that governs use of the evaluation product.

**RECYCLING**. The Reference Material is not to be disposed as an urban waste. At the end of its life cycle, differentiated waste collection must be followed, as stated in the directive 2002/96/EC.
